FINANCIAL COMMITMENT

The Goal Setter agrees to provide two sums of money to the Accountability Partner, which will be distributed to a person or organization the Goal Setter absolutely despises (the "Recipient"), in the event the goal is not achieved as outlined below:

1. First Sum ("Warning Amount"): \$_____. This amount will be given to the Recipient by the Accountability Partner as a warning if it becomes clear that the Goal Setter is falling behind or unlikely to meet the goal by the deadline. The Accountability Partner may use their judgment to determine when this is necessary. This amount is designed to be uncomfortable and is based on the net worth of the Goal Setter at the time of signing this agreement.

2. Second Sum ("Final Amount") \$_____. This amount will be given to the Recipient by the Accountability Partner if the Goal Setter fails to achieve the goal by the deadline. This amount is designed to be painful and is based on the net worth of the Goal Setter at the time of signing this agreement.

NO BLAME CLAUSE

The Goal Setter agrees that, once the money has been handed over to the Accountability Partner, the Accountability Partner is under no obligation to return it. The Goal Setter understands and agrees that the Accountability Partner is not responsible for any failure by the Goal Setter to achieve the goal. In the event that the Accountability Partner distributes the funds to the Recipient, they are acting solely based on the terms outlined in this Agreement and shall bear no liability or blame for the Goal Setter's inability to complete the goal.

DECISION TO DISBURSE FUNDS

The Accountability Partner agrees to communicate with the Goal Setter in good faith about their progress. However, the ultimate decision to distribute the Warning Amount or the Final Amount shall rest with the Accountability Partner, using their reasonable judgment. The Goal Setter agrees to respect and abide by the Accountability Partner's decision.

CONFIDENTIALITY

Both parties agree that all discussions and details regarding the goal, progress, and financial commitments shall remain confidential unless explicitly agreed otherwise.

TERMINATION

This Agreement may be terminated by mutual consent of both parties, in writing, at any time prior to the disbursement of the Warning Amount. After the Warning Amount has been distributed, this Agreement may not be terminated.

GOVERNING LAW

This Agreement shall be governed by and construed in accordance with the laws of the State of ______.
